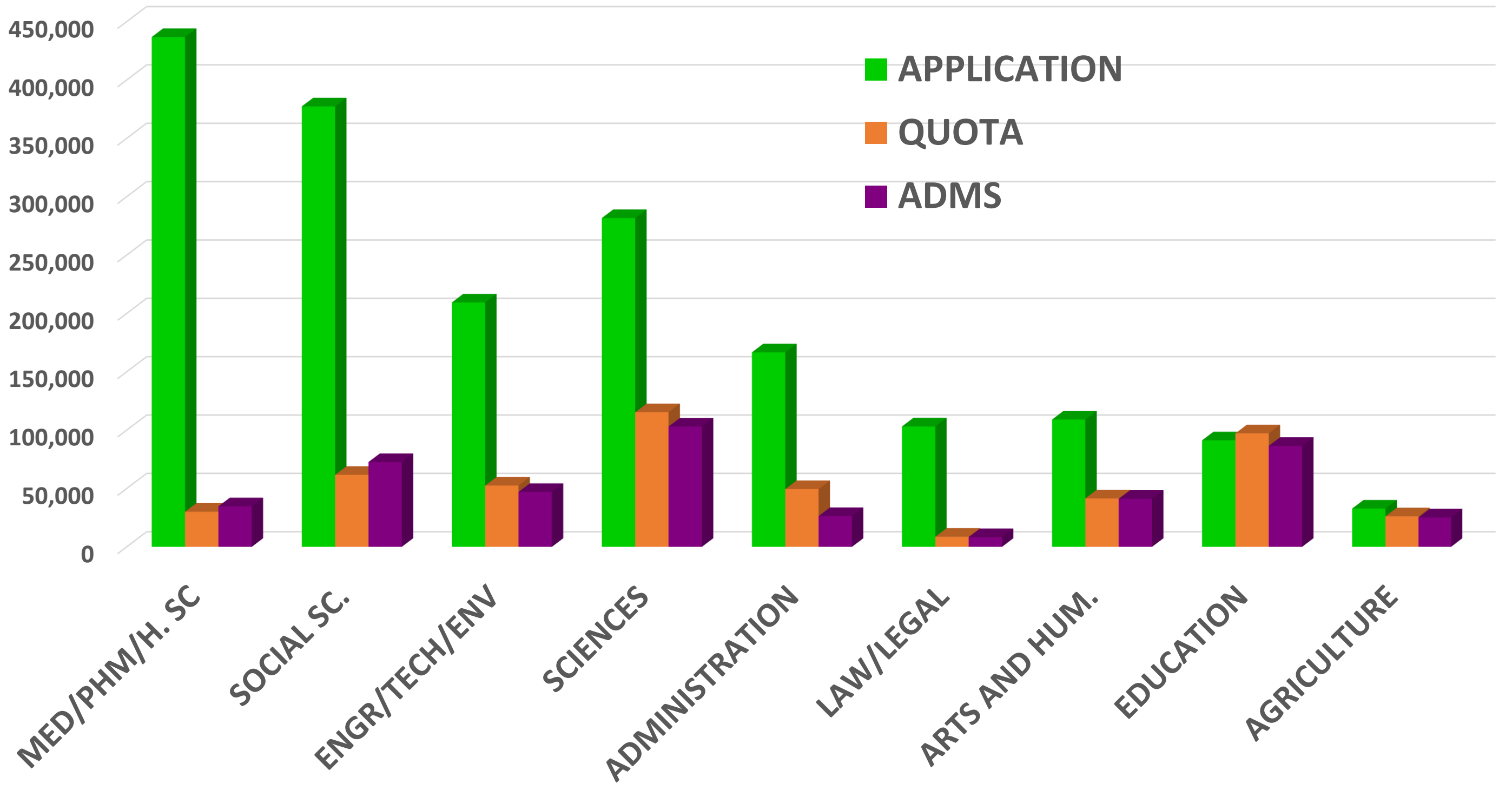

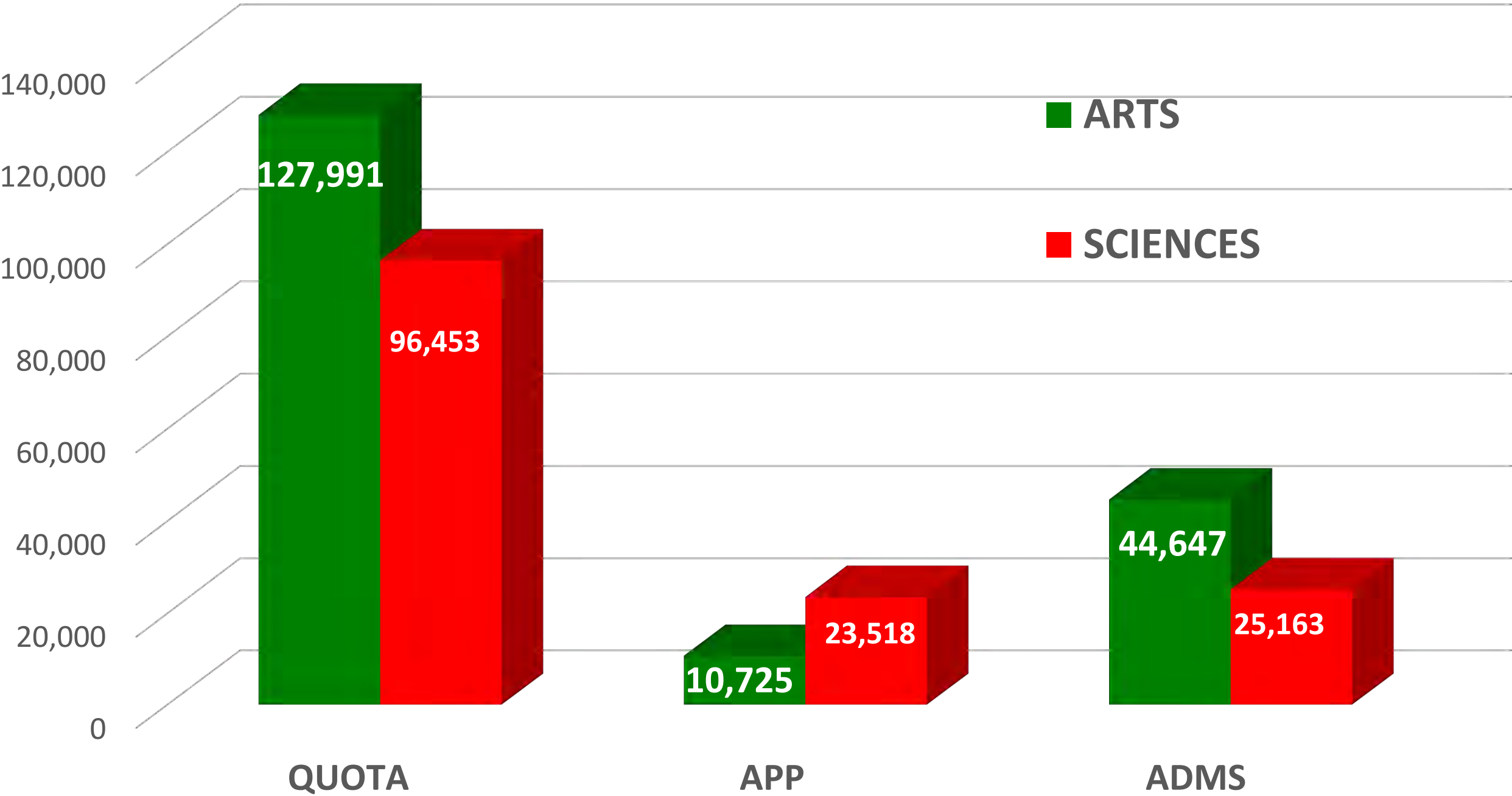

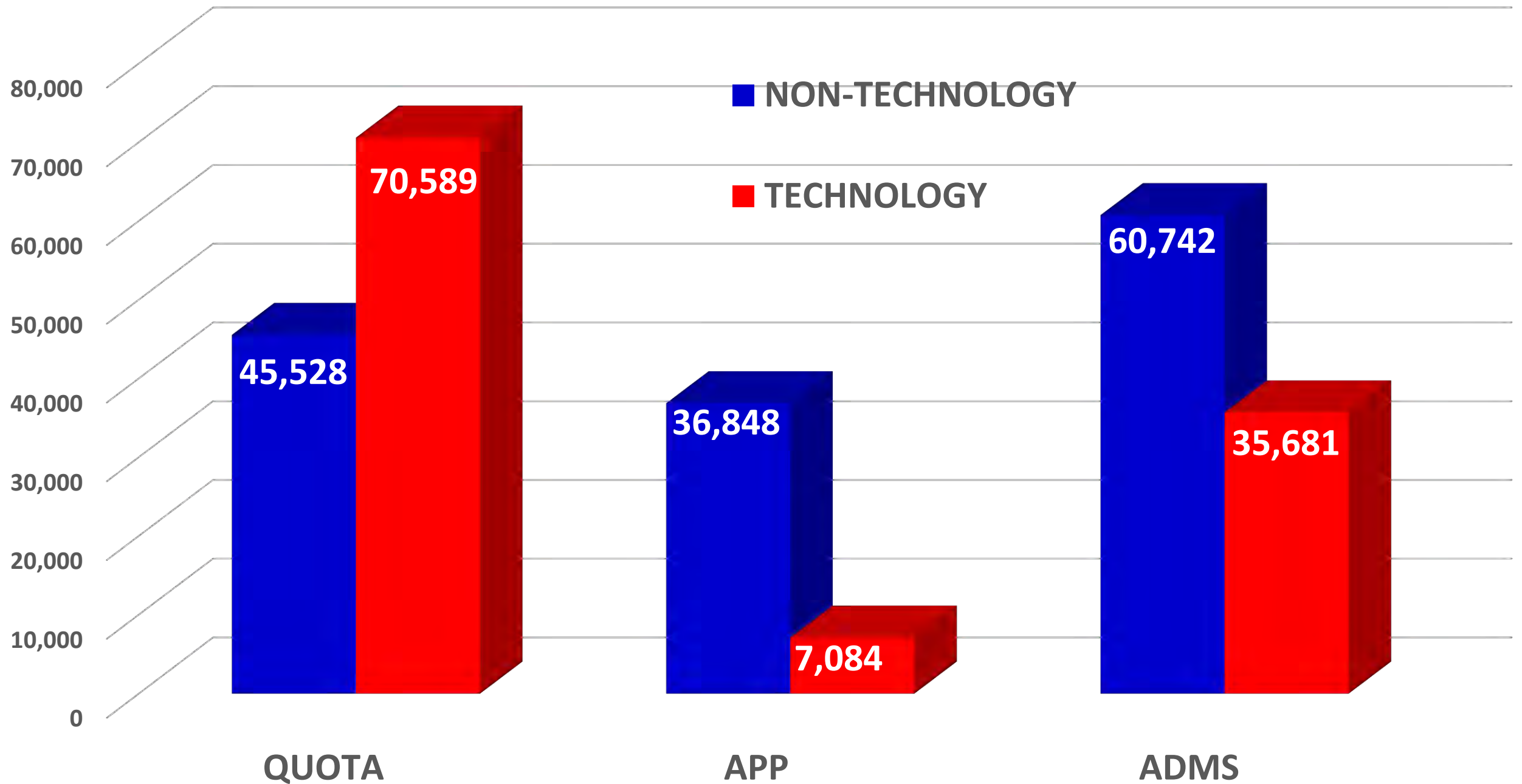

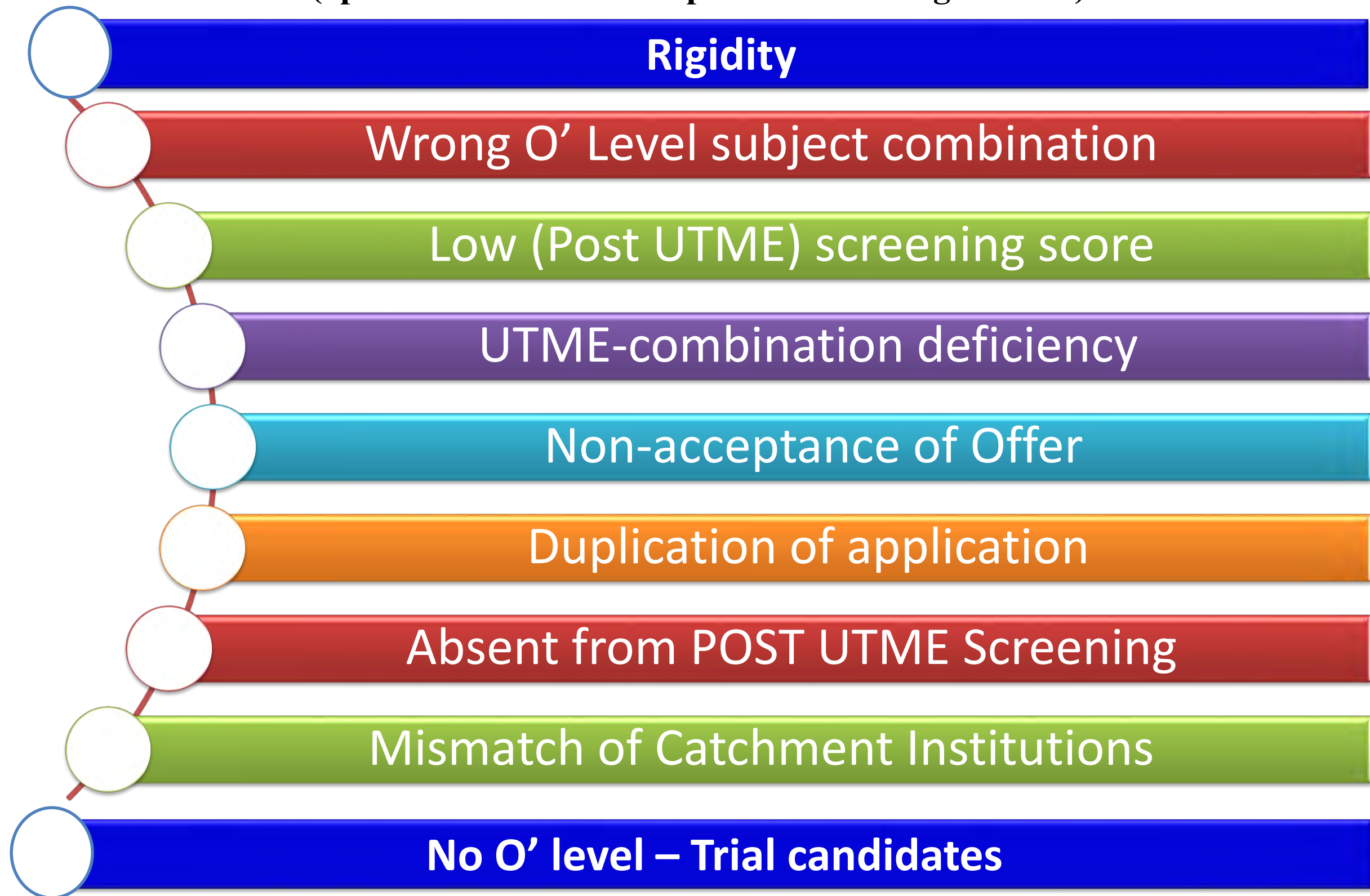

Warehousing of Candidates into Institution's Portal

## **Adekunle Ajasin University, Akungba (AAUA)**

- Adamolekun Bernice - 97012025AJ
- Applied to Law with 280 score to UNIBEN
- Not ranking enough with 61.5 average
- Initiated and accepted English Education (UNIBEN)
- Now purportedly offered Law at AAUA through University's portal
- A candidate not available at all in CAPS under AAUA but now offered 'admission' and acceptance fee paid before protest and cannot be properly admitted into AAUA.
- Months to reverse/delete & release in UNIBEN

- MBBS

Quota = 200

After admitting 106 on CAPS

Released additional 448 on the University's portal

Whereas there are 342 qualified unadmitted on CAPS

- LAW

Quota = 250

Admitted 125 on CAPS

Released another 240 on University's portal

# **USING INSTITUTION PORTAL TO VIOLATE ADMISSION PROCESS (cont'd)**

Warehousing of Candidates into Institution's Portal

Mashood Abiola Polytechnic, Abeokuta (MAPOLY)

- **CLAIMED Quota** = 12, 587
- Not a single candidate was admitted on CAPS
- 'Admitted' over **10,795** and went on to receive acceptance fee from **5,950** candidate not yet proposed to JAMB

- Musa Ishaq - 96072786HA
- Course Applied - Cyber Security
- School Portal - moved to Physics
- He innocently changed his programme to Physics whereas he is qualified for Cyber Security

# USING INSTITUTION PORTAL TO VIOLATE ADMISSION PROCESS (cont'd) Ahmadu Bello University, Zaria

- **Thomas Goodness Shekwobyalo**
- Registration number 96835876JH
- UTME Score – **302**
- Qualified to be admitted to MBBS but claimed to be persuaded to change Anatomy on the University portal
- University refuted the claim
- On JAMB's insistence, she was offered MBBS but politicized and she rejected

## Nigeria Police Academy, Wudil

- 'Changed' programme of candidates through Academy portal without the consent of the candidates
- 'Admitted' candidates who were already admitted genuinely into other institutions through CAPS and could not upload them on CAPS again
- 'Admitted' candidates who did not choose the Academy as first choice. **How?**

### REQUEST FOR INTERVENTION IN MY ADMISSION STATUS AT UNIVERSITY OF NIGERIA, NSUKKA

I got admitted into the 200 level Direct Entry programme in the Department of Nursing Sciences of the University of Nigeria (UNN), Nsukka, in the 2019/2020 academic session. My name was published in the Primary Admissions (Merit) List following sterling performance in the university's screening examination. I accepted the admission, paid the school fee, did all the necessary registrations and started lectures. I was patiently awaiting the JAMB admission letter.

On May 13, 2020, I read on JAMB CAPS portal that the university had requested my transfer to the department of Medical Radiography and Radiological Sciences. I rejected this transfer request on JAMB portal, preferring to remain in Nursing Sciences department. This is because I am already a Registered Nurse with the Nursing and Midwifery Council of Nigeria and, therefore, cannot change department at this level of my professional career. I also noticed that the university had changed my department to Medical Radiography and Radiological Sciences in my university's portal profile.

### ADMISSION OF DIGNITY WILFRED ONABE INTO THE NIGERIAN POLICE ACADEMY, KANO

I write to thank you for granting admission to **DIGNITY WILFRED ONABE** into the Law programme of the Police Academy, Wudil, Kano State.

2. We are however constrained to inform you of a deliberate attempt to change the course offered to **DIGNITY WILFRED ONABE** from Law to Management Sciences, without justification.

3. You may recall that you directed the Deputy Registrar of the Police Academy who coincidentally came for submission of admission list and one of your Directors of IT, not to change the Law programme already offered to the candidate. Also recall too, that you summoned the Commandant of the Nigerian Police Academy to see you on this and other Sundry matters regarding the admission.

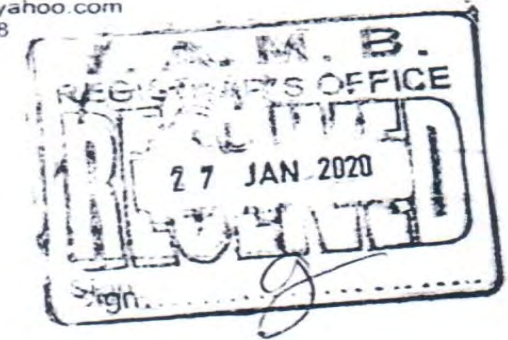

It is rather shocking to note that our client's name is not contained on the merit list neither is it on the supplementary list. Our client's private investigation reveals that her admission slot was sold by the officials at the admission office of the University of Abuja. As it is, our client has no other option than to channel her grievance to you as the head of the university in order for you to urgently intervene in ensuring that this anomaly is corrected.

It is hoped that this petition would be treated with utmost urgency having regard to the special circumstance of this complaint, the fact that time is of the essence.

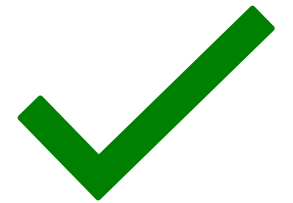

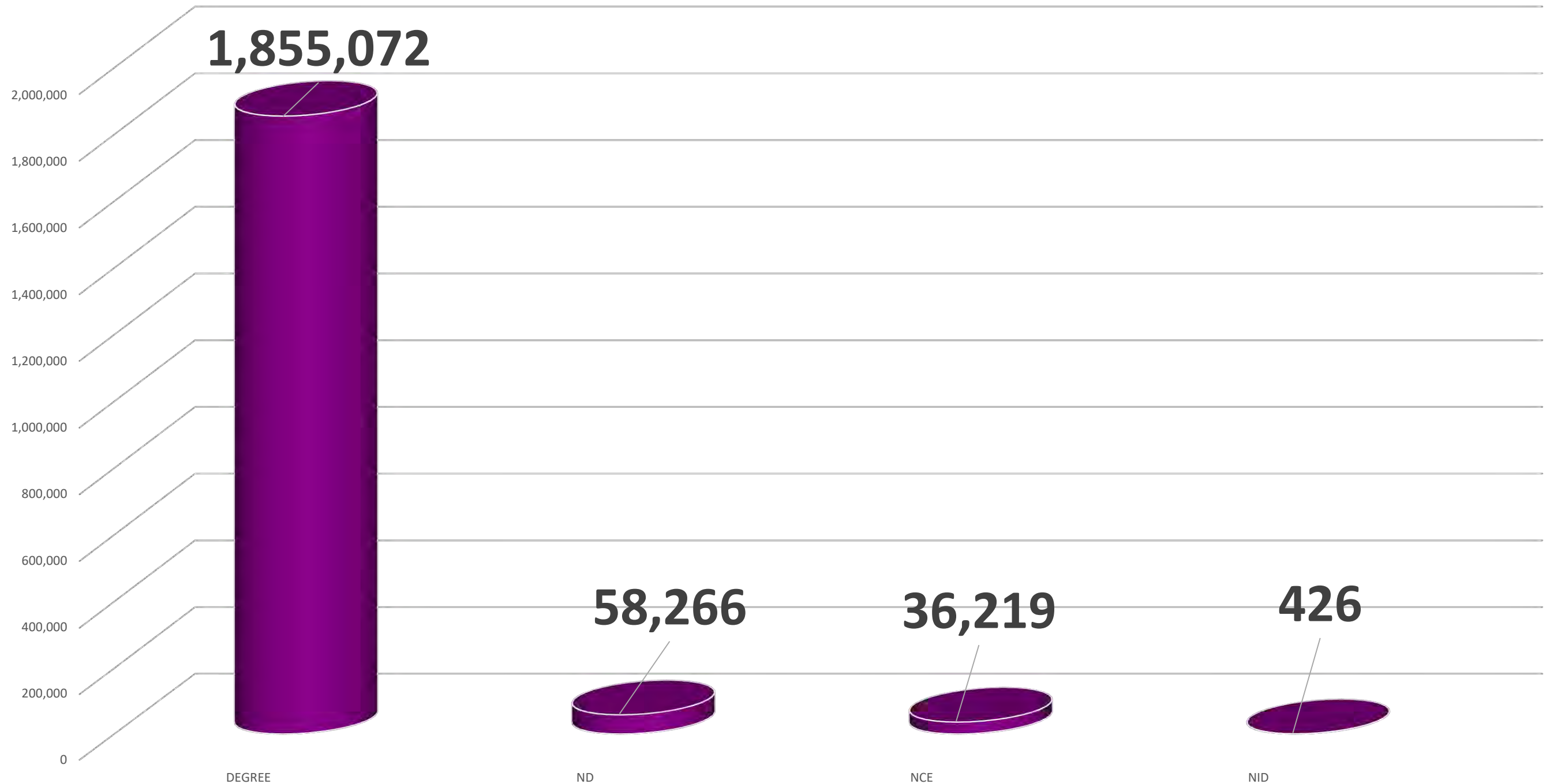

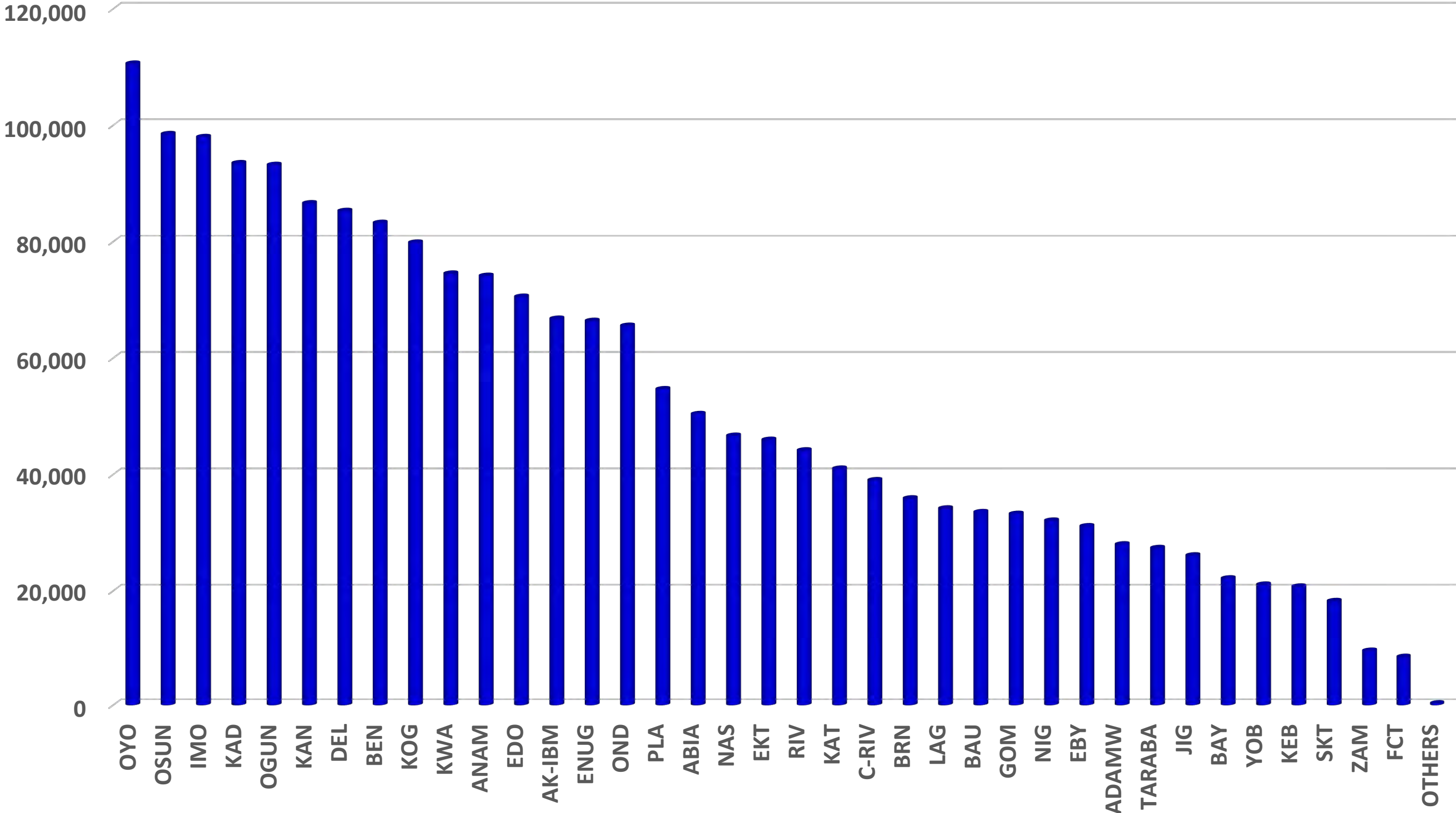

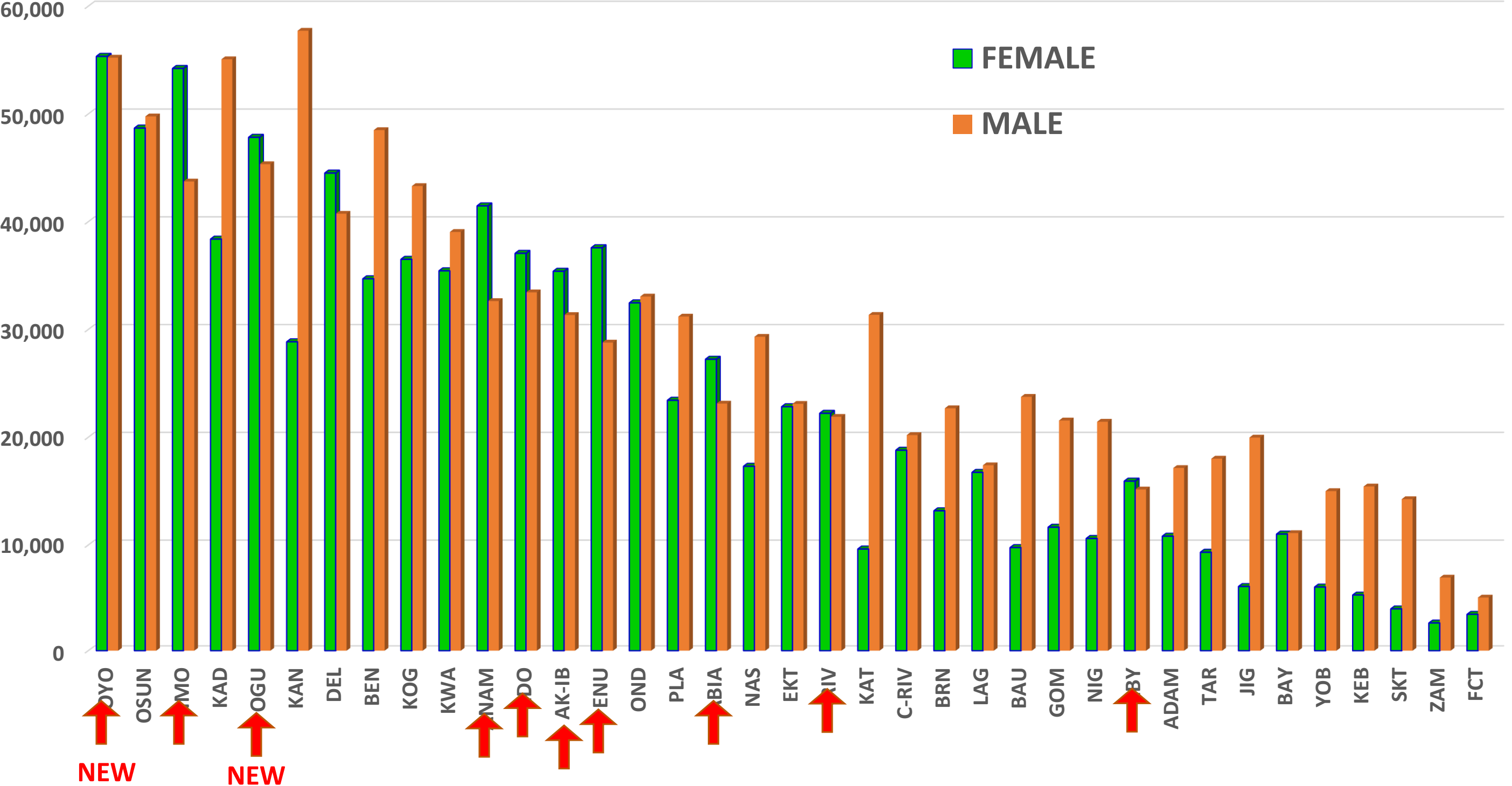

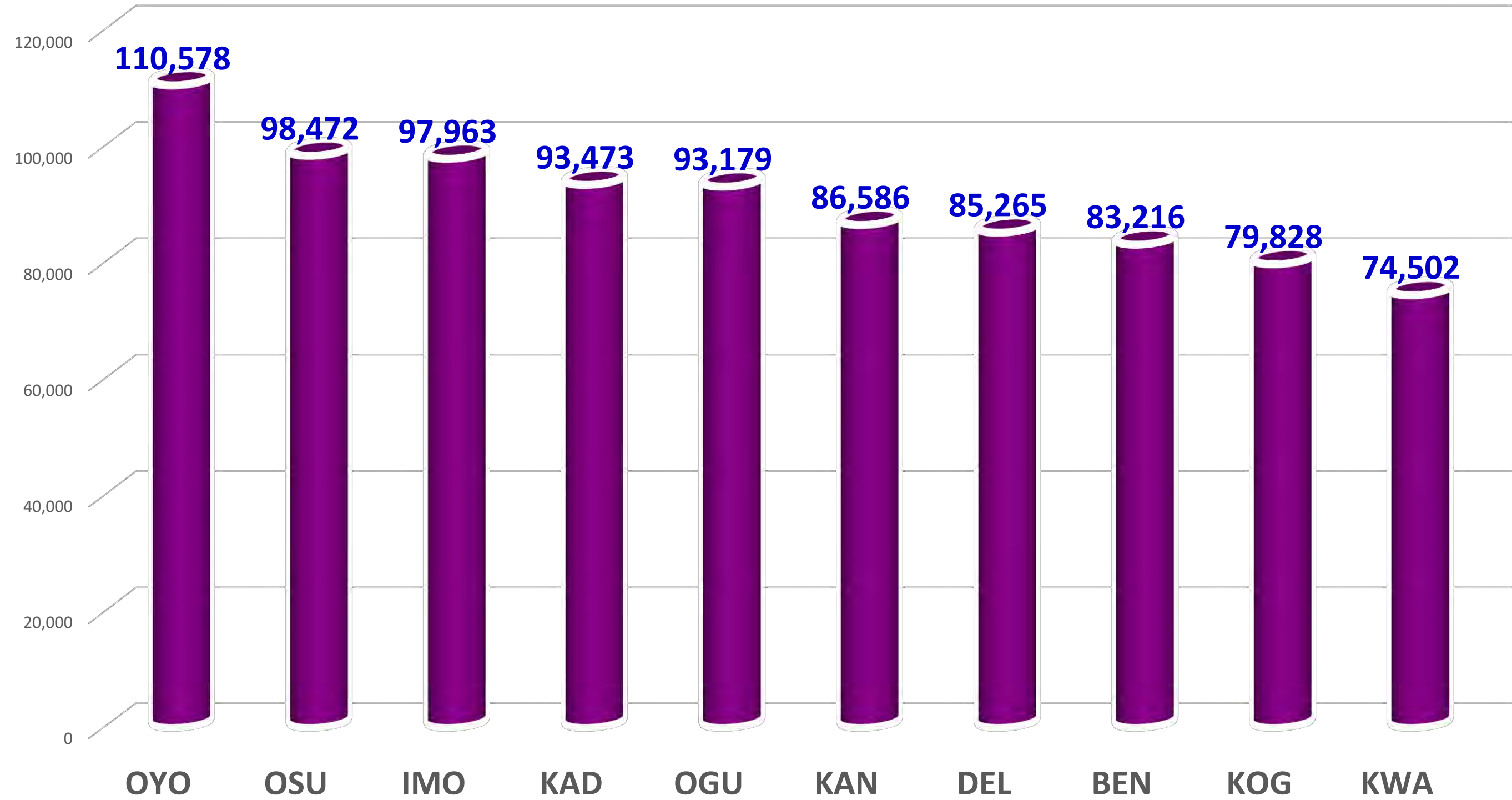
**GRAPHICAL REPRESENTATION OF 2020 UTME

GRAPHICAL REPRESENTATION OF 2020 UTME APPLICATION STATISTICS BY STATE OF ORIGIN & GENDER

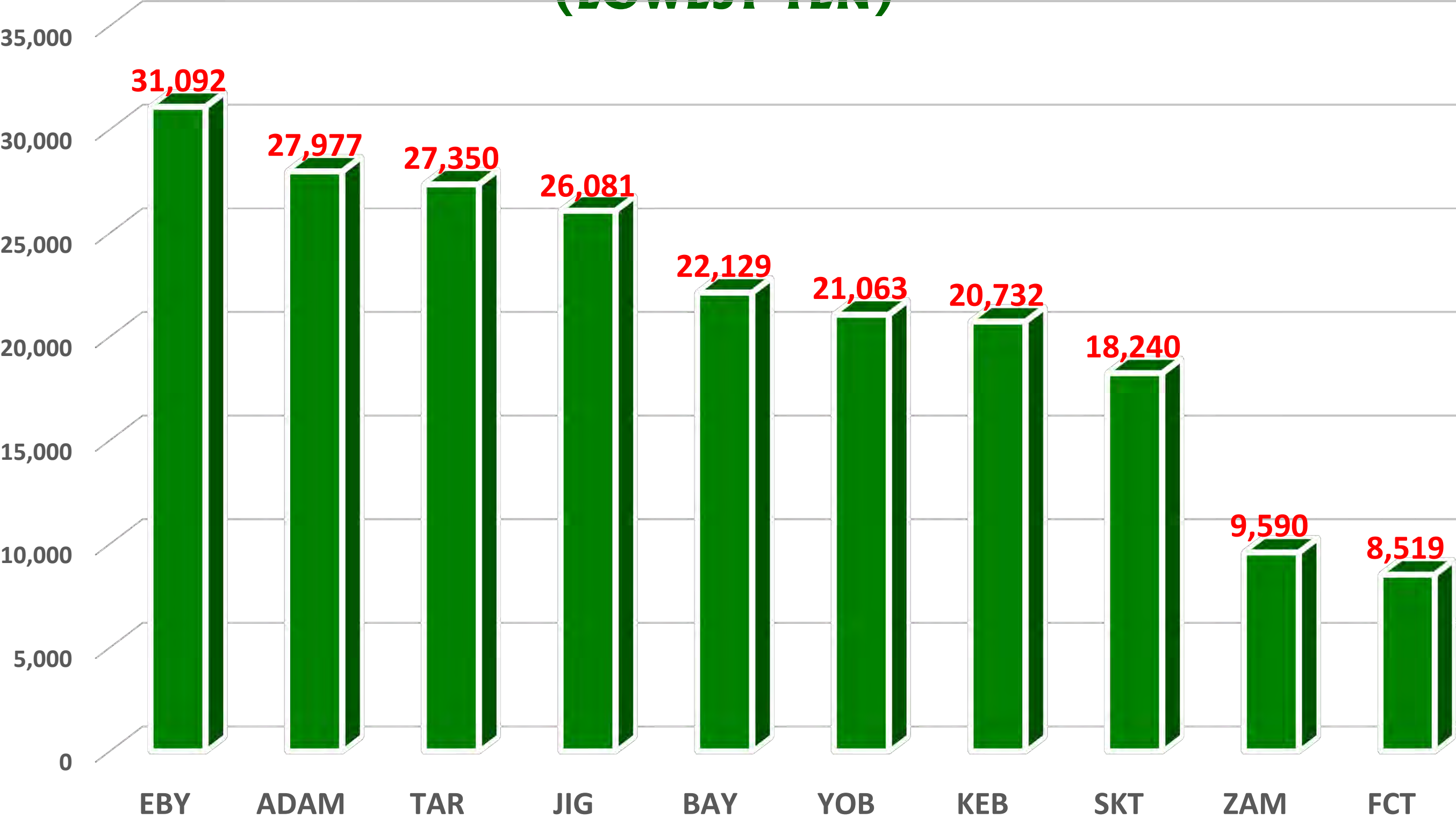


# 2020 UTME APPLICATION STATISTICS BY STATE OF ORIGIN (TOP TEN)

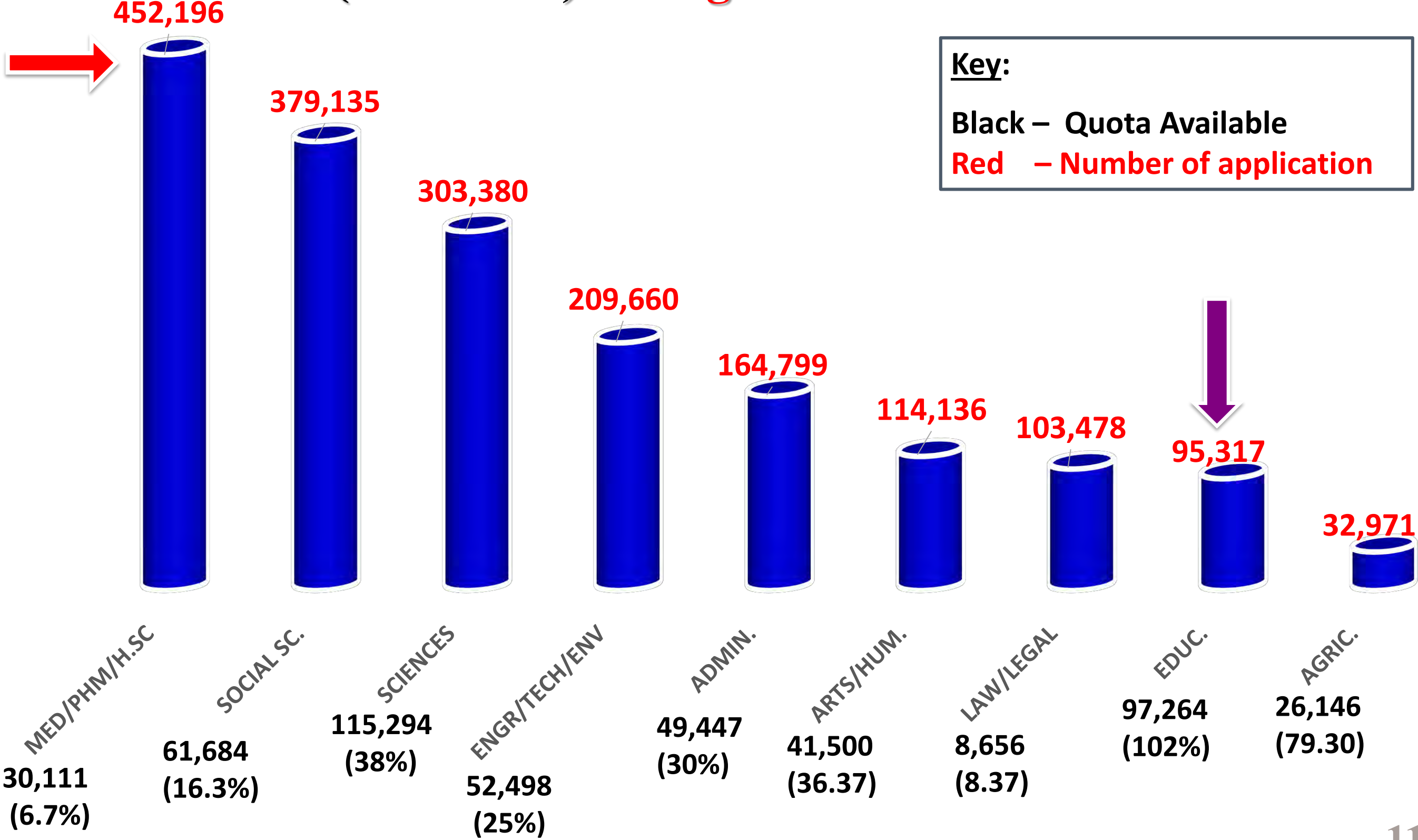

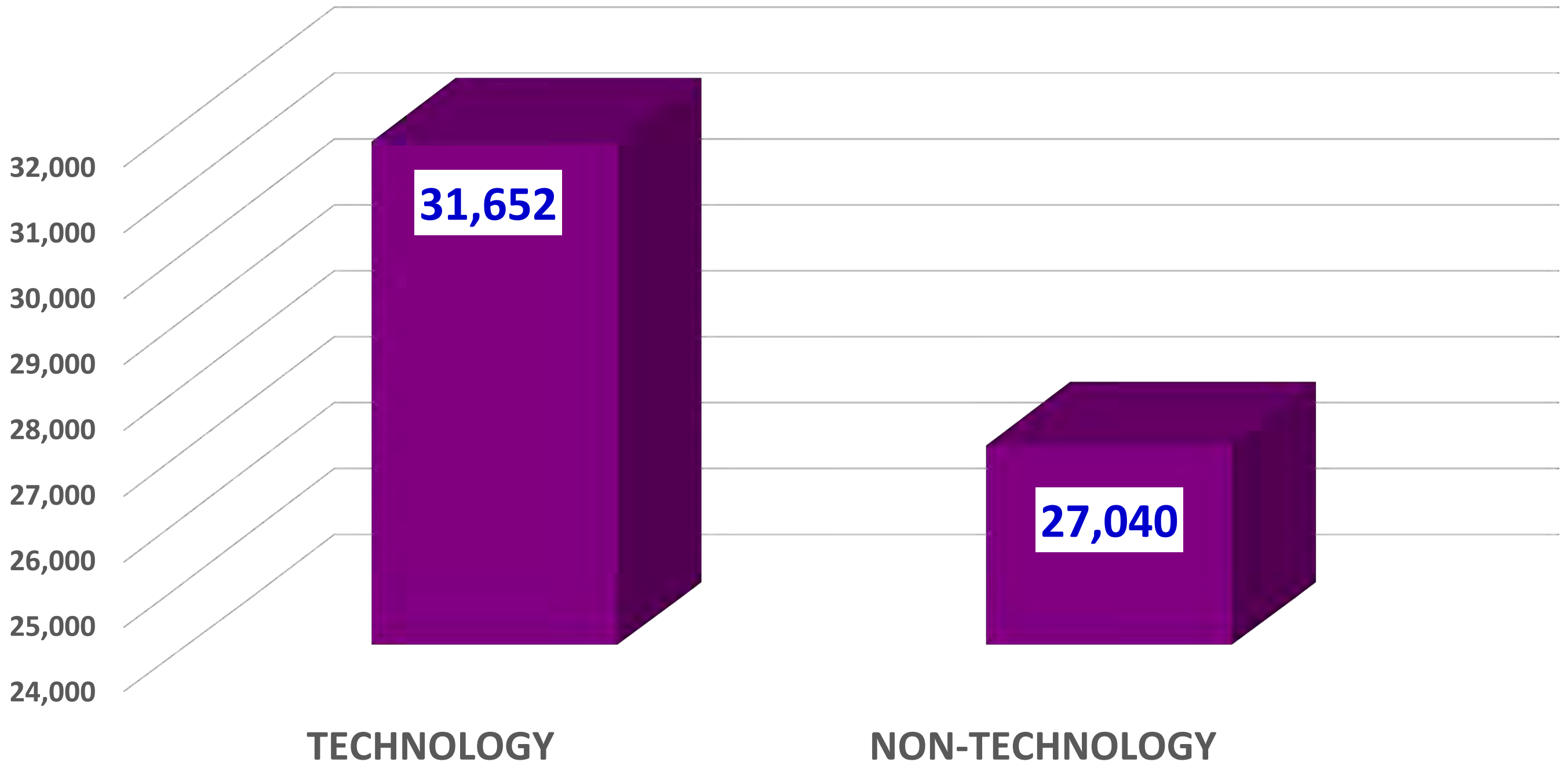

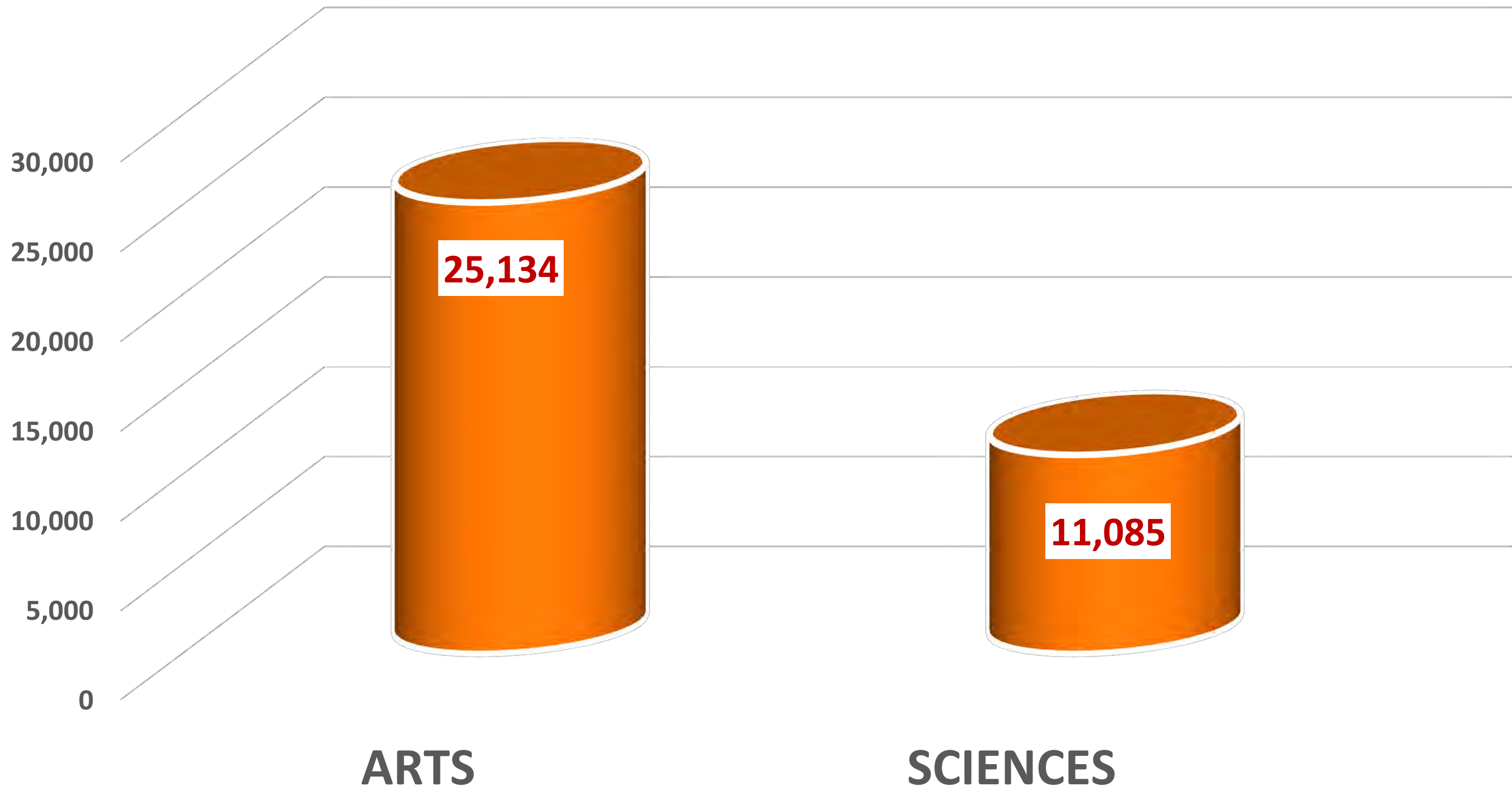

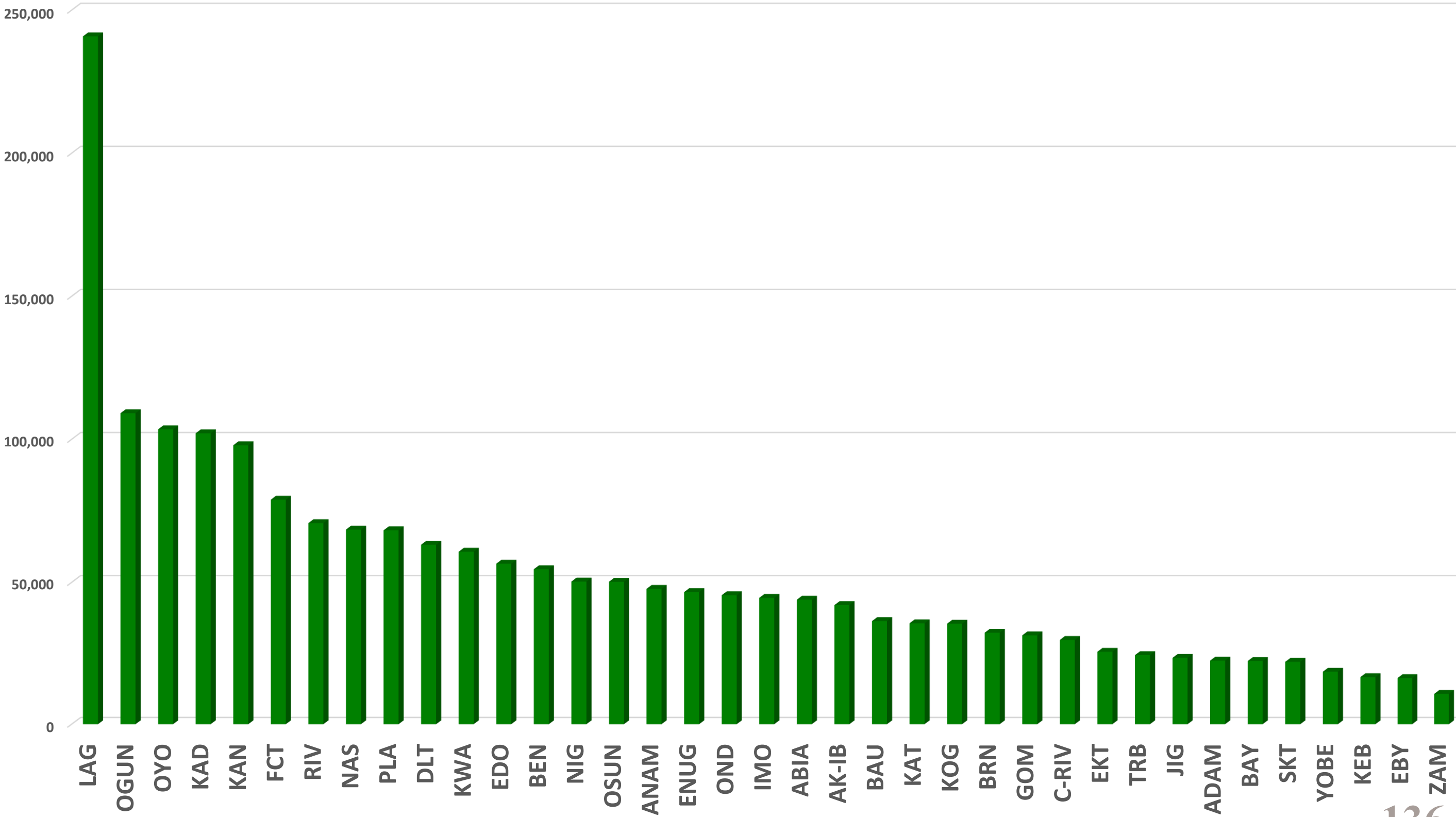

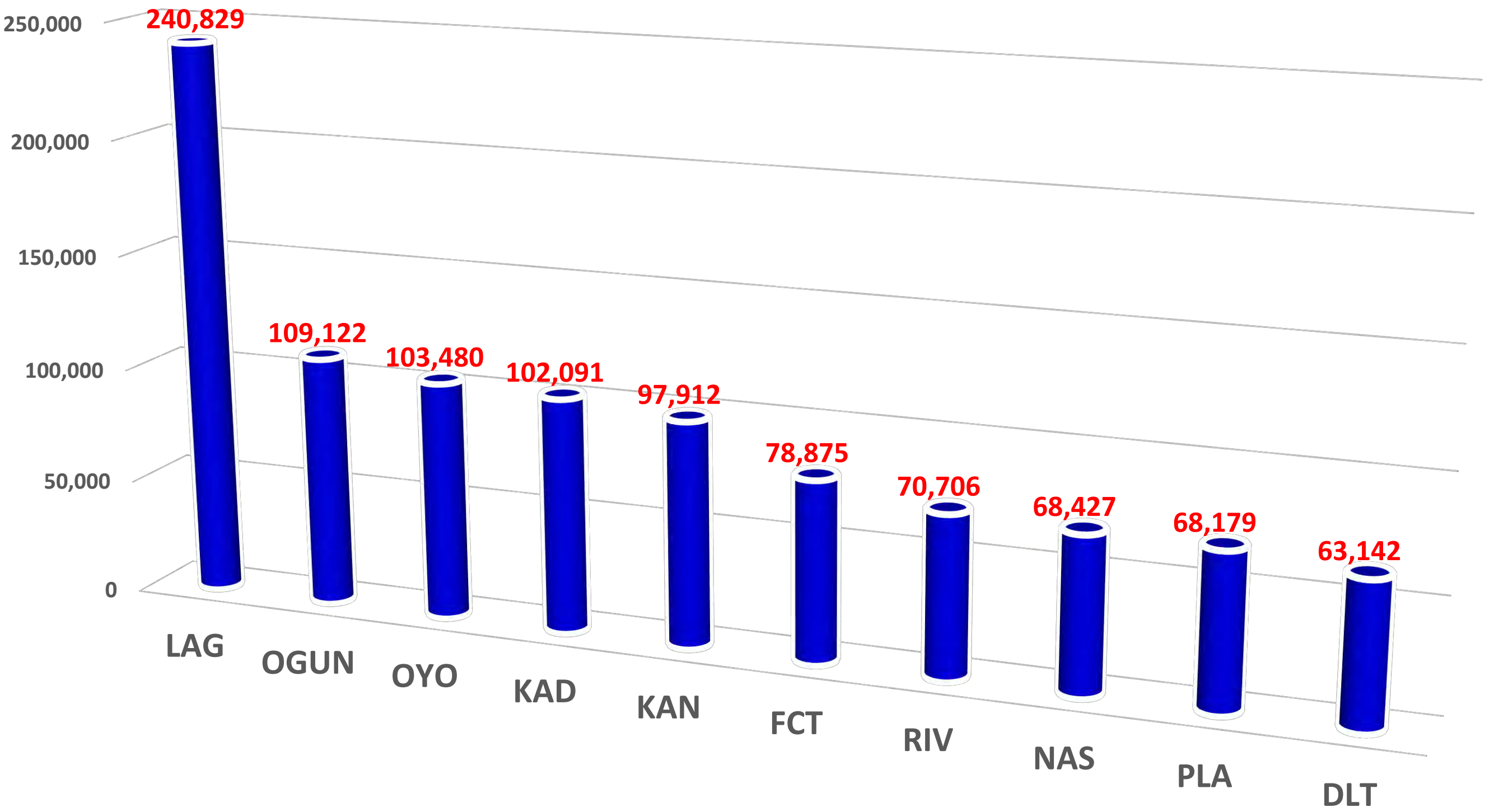

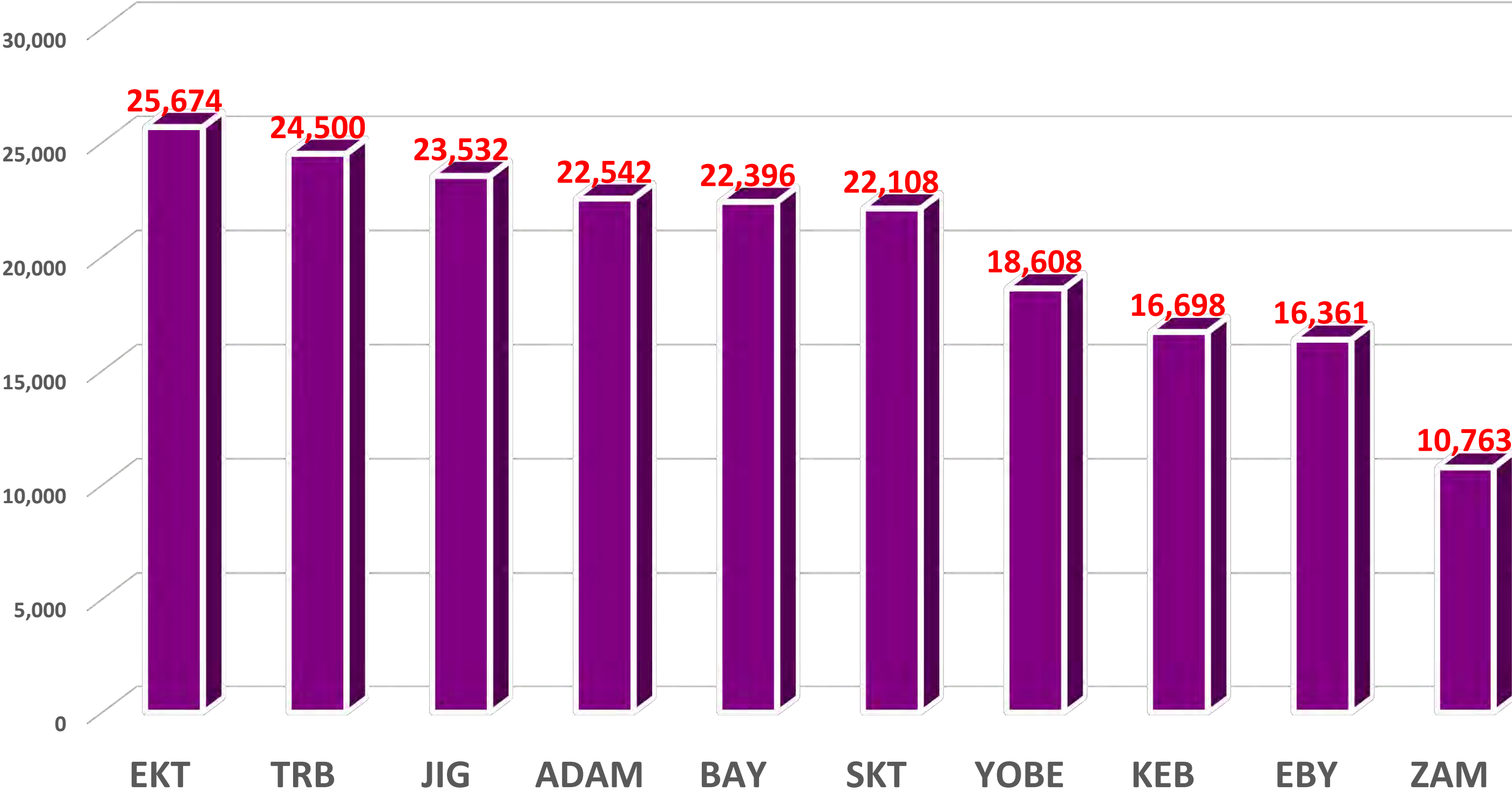
GRAHICAL REPRESENTATION OF 2020 UTME

# **SCORE STANDARDISATION IN PUBLIC EXAMINATION**

- ✓ The transformation of scores as done with public examination has continued to generate public discussion with many commentators taking very misleading paths. I will want to seize this opportunity to again explain the much-misunderstood concept which has led some people believing that scores are given to candidates even when they answer no question
- ✓ Score transformation or standardization is a procedure for transforming candidates' raw scores in different subjects taken by each candidate to a common scale with uniform metric or units, which is the globally-accepted procedure applied in scoring in a large-scale norm-referenced test.



## **SCORE STANDARDISATION IN PUBLIC EXAMINATION** (cont'd)

To address the public outcry against what is termed unmerited score, particularly for those who sit the examination but do not attempt any question, the Board has backed the idea of transforming the zero scores of those who attempt the examination questions but get them wrong, while there would be no transformation for those whose zero scores are from lack of attempt or because they were absent



## SCORE STANDARDISATION IN PUBLIC EXAMINATION (cont'd)

- ✓ JAMB has, therefore, introduced the concept of nominal zero score that will be notated as **zero asterisk (0\*)** for candidates who were present but failed to attempt any question.
- ✓ Candidates who are absent from the examination would continue to be marked absent without any scores.
  - all absentees would be marked absent and would have zero scores

## SCORE STANDARDISATION IN PUBLIC EXAMINATION (cont'd)

The position of JAMB is that all candidates who are absent from the examination and those who sat the examination and did not attempt any question would **score zero** and their zero score would **not be transformed**

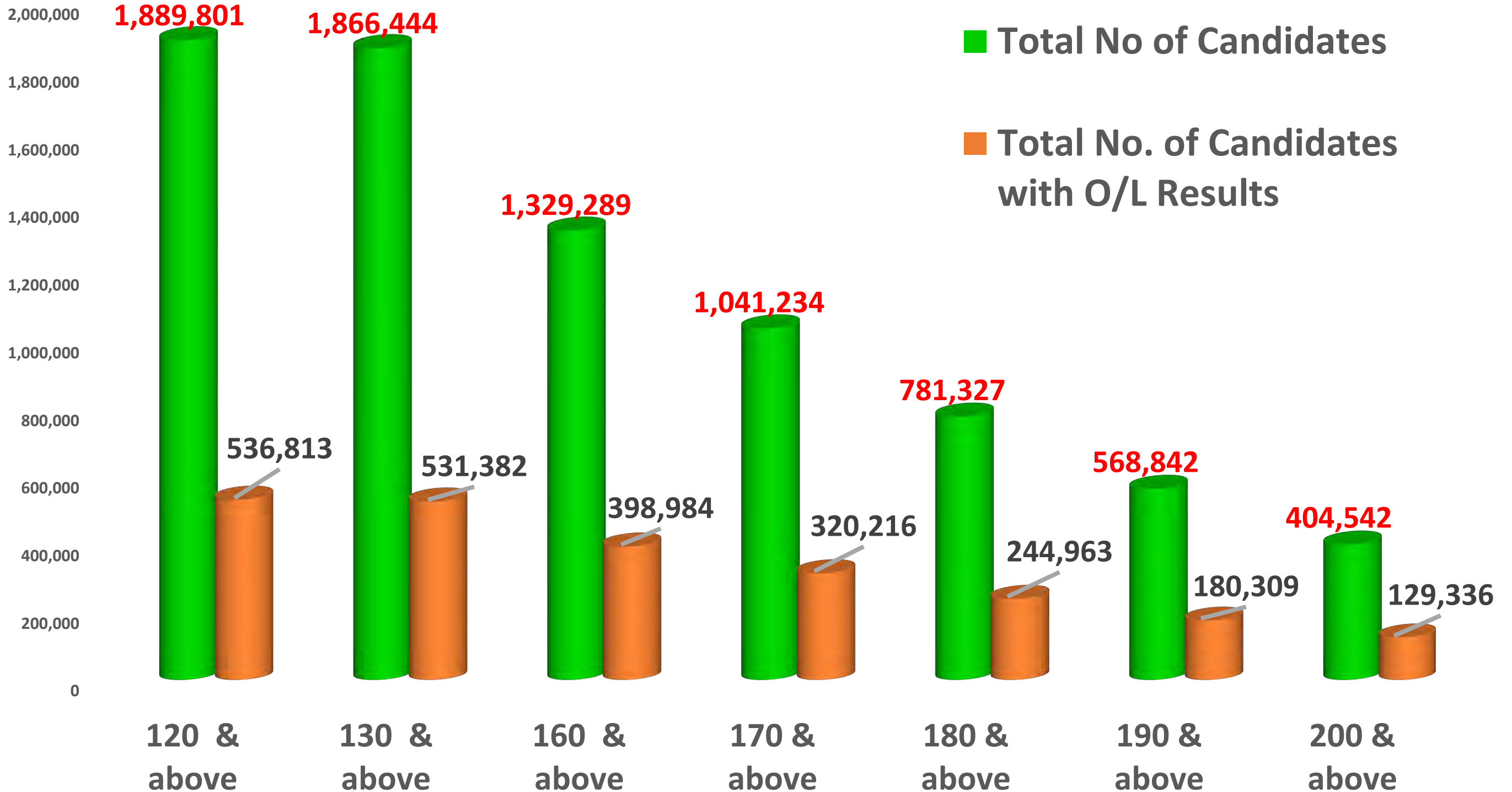

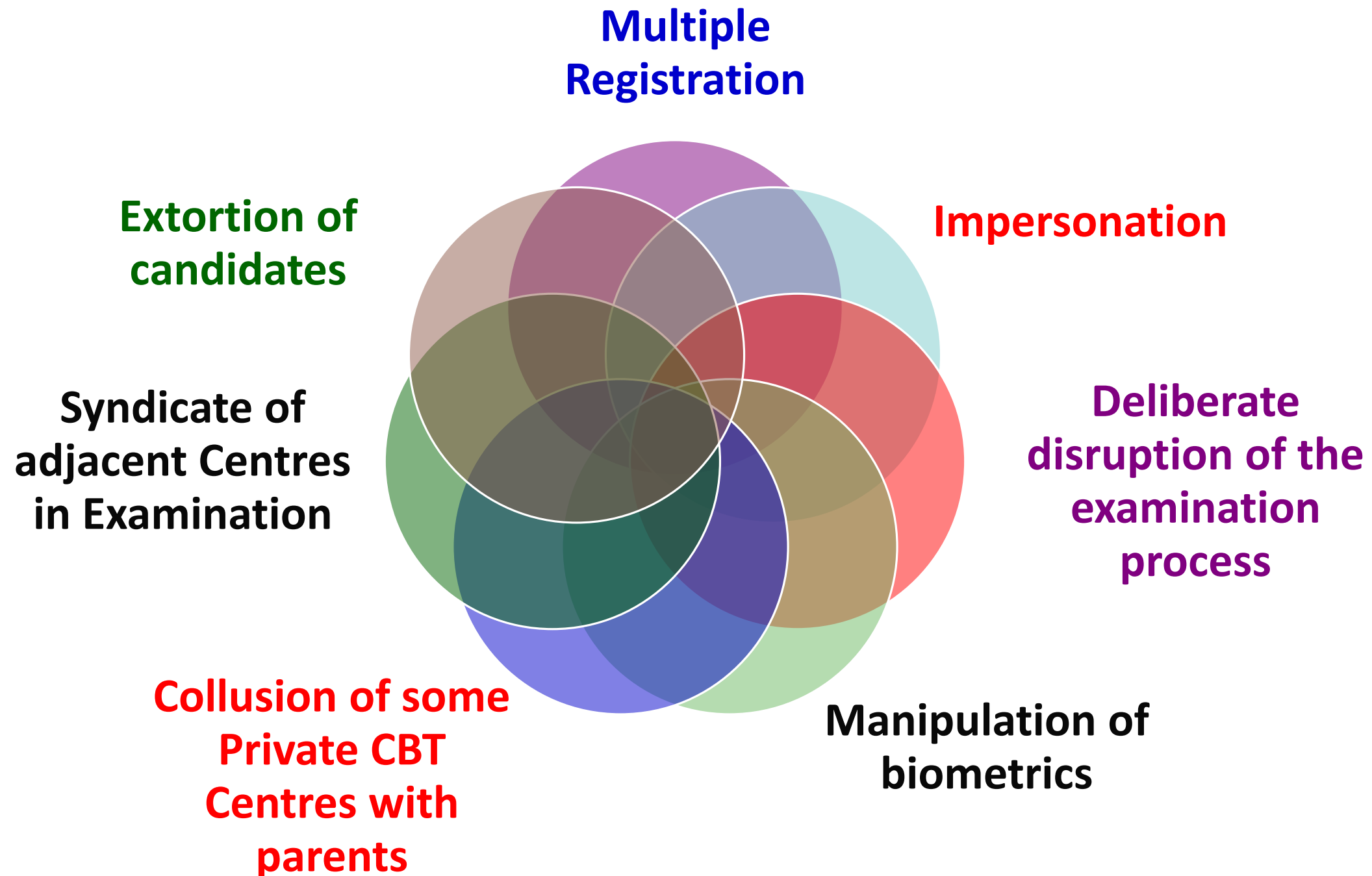

# STRATEGIES OF MALPRACTICE





## **Curbing Malpractice by NOT Capturing of Fresh Images and Biometric**

- ✓ Capturing of fresh facial and finger biometric images of candidates **encourages impersonation** and substitution of paid examination takers with real candidates who must have engaged the paid examination takers for the SSCE and UTME.
- ✓ Concerted efforts by JAMB, other educational assessment bodies and the NYSC have implicated tertiary institutions (few of them unwittingly in the scandal.
- ✓ You are therefore requested not to capture fresh images and biometric

# FORGERS AND FRAUDSTERS AT IT AGAIN:

- ✓ Cluster of fraudsters who had been benefitting from examination malpractice continue to **forge the Registrar's signature**, writing fictitious news items that JAMB website had crashed and all examinations written were cancelled
- ✓ Again, they were mistaken. **We are grateful to Government especially FME**

# ADDITIONAL FEATURES ON CAPS

## Movement of Candidates

Before a candidate can be moved or transferred to another programme, they would be transfer alert (**notification from CAPS**) to the candidate to either accept or reject the movement

If s/he presses YES,

**COVID\_19 induced delay (No O/L) for many but NDA is ready to go – others please notify us.**

**Cut off date & Admission exercise can't be earlier than 20<sup>th</sup> August, 2020**

**No institution would be able to finalise admission exercise until after cut-off date**

## ADDITIONAL FEATURES ON CAPS (cont'd)



No institution would be able to move candidates into merit level unless ALL positive candidates above him/her are admitted either by merit, catchment or ELDS

After upload of O' level by a candidate, any admission to be done MUST consider him/her

# Condonement of Claim of Previously Illegitimate Admission Without JAMB Registration Number

## REVELATION



Candidates who earlier sat for the UTME in the past apply for condonement of illegitimate admission to be able to have **a new date of birth & name** for the purpose of participation in National Service

## SOLUTION

- ✓ Backend programme detects such candidates and approvals not granted
- ✓ The list of such candidates & institutions are being compiled
- ✓ The Board will soon prosecute the candidates & the institutions (including its Heads) for such application

# **NEED FOR REVIEW OF ADMISSION CRITERIA**

## **reminder!!!**

### **CAPS REVEALED**

**More poignantly the need to review the formula to make our institutions more National (as envisaged in the inclusion of Catchment Area in the criteria – which has been so abused)**

### **Admission needs to be**

- ✓ International (inclusion of foreign candidates)
- ✓ More inclusive (inclusion of special needs candidates)
- ✓ more realistic (restoring and recognising some Discretionary Admissions)
- ✓ Nationalisation of localised National Institutions

***A new formula is long overdue to be proposed to the National Council on Education***

# 2020 ADMISSION TIMELINES AND CALENDARS



- ✓ JAMB & Tertiary Institutions are to ensure that Admissions periods are sacrosanct and must be followed and adhered to

- ✓ 1<sup>st</sup> choice admissions must be done during the period earmarked for 1<sup>st</sup> choice



- ✓ other choices must be processed during the timelines set out for them

## 2020 ADMISSION TIMELINES AND CALENDARS (cont'd)



- ✓ JAMB would communicate Admissions Programmes, Calendars & Timetables to Tertiary Institutions immediately after this Policy Meeting
- ✓ At the end of the 1<sup>st</sup> choice period, **all candidates not admitted would be pulled out** of the institutions' platform on CAPS & be made available to other willing institutions

## **PROFILE TRANSACTION**

### **UNDUE INFLUENCE/THIRD-PARTY INTERFERENCE**

- ✓ The Board has banned all third-party interactions on its portal for any of its services
  - cases have been reported with conflicting authorisation for changes on candidates' data, majorly between candidates and their parents or guardians
- ✓ Fraudsters taking advantage of the naivety of some candidates to collect their vital access codes to effect unauthorised changes on their profiles
- ✓ Consequently, **nobody, including parents or guardians** or any proxy, would have access to transact any business on candidate's profile because fingerprint (or OTP) would be required

It is the Board's conviction that candidates deserving tertiary education should be able to personally perform all these operations as required



# **JAMB SUPPORT SYSTEM – TICKETING**

## **Reminder!!!**

- ✓ candidates no longer need to travel to JAMB offices to access certain services.
- ✓ The Board uses the ‘ticketing system’ where a candidate or anybody desiring the Board's services can send their complaint(s).
- ✓ Responses are given within 24 hours.
- ✓ It has a tracking number that is issued once a ticket is raised. If not attended to, the number can be use as evidence to track the officer scheduled who would be sanctioned
- ✓ The system is designed to eliminate any stress associated with accessing the Board’s services

## (Using IBASS)

- ✓ Now automated and electronic-online through IBASS (**Integrated Brochure & Syllabus System**)
- ✓ Access point: ***www.jamb.gov.ng***
- ✓ Each institutions has secured access credentials it will collect through its registered e-mail address on CAPS
- ✓ Each institution views its present requirements & makes online request for amendment, deletion or addition on the platform
- ✓ All approved requests would be communicated vide the platform provided it is within the approved guidelines of the respective Regulatory Agencies (**NUC, NBTE or NCCE**)

# WAIVERS FOR ADMISSION

## Reminder!!!



advantage

- ✓ JAMB received requests for lowering of minimum scores from institutions as a waiver to allow candidates to be admitted through CAPS
- ✓ Institutions should take advantage of IBASS
- ✓ Make a realistic requests including UTME subjects combination & O' level credit passes
- ✓ Remedial students must also have minimum institutional score
- ✓ Head of institutions or Registrars should personally make such requests

# WAIVERS FOR ADMISSION

## Example of Unrealistic Request

A University requested JAMB to **totally waive the consideration of UTME** subject combinations for candidates seeking admission to the University but to rely only on overall score only

- ✓ Prolonged Investigation and Prosecution
- ✓ Associated Costs Involving Travels, Allowances, Attendance of Court and Legal Fees
- ✓ Inadequate CBT Centres in Some Parts of the Country



# Way forward

- ✓ Partnering security operatives & relevant agencies on cyber crimes
- ✓ Engaging the machineries & sponsoring them in order to tap from their knowledge
- ✓ Movement of some services to the registration portal in order to prevent extortion of candidates
- ✓ Dedicated Courts for Examination Malpractice
- ✓ Open Book Examination to Discourage Cheating
- ✓ Political-Will and Concerted Efforts at adopting **Single Identity for all Citizens** to Discourage Impersonation
